The Health and Care Bill is the most significant piece of health legislation this parliament, and will shape the structures of the NHS, how services are delivered, and improvements to population health over the next decade.

Its purpose is to lay the foundations for a more integrated, efficient and accountable health and care system

The legislative changes will help to implement the recommendations of the NHS Long Term Plan and will build upon the collaboration and new ways of working developed during the pandemic.

The overarching objectives of the changes are to:

Improve integration within the NHS and with other health partners by giving new Integrated Care Systems (ICSs) statutory powers and responsibilities to deliver services and improve health outcomes to a population within a local region.


Usher in a new era of greater collaboration, instead of competition, within the health system and removing the barriers and bureaucracy to achieving this.

Give the Government greater control and accountability over different parts of the health and social care system.
